Pursuant to Alaska Statutes, AS 34.35.050 through 34.35.120, Frontier Supply Company and/or The Plumbing Showcase may assert a Materialman's Lien upon the premises to which purchased materials are incorporated. All account balances are due and payable in full on the 10th day of the month following the date of purchase. If an account balance is not paid in full by the 25th of the month following the date of purchase, the account will be considered delinquent (past due) and a late payment charge (at the maximum rate allowed by law, AS 45.45.010) will be added to the unpaid balance. Such late payment charges will be added on the 26th day of each month so long as the account remains past due. The late payment charge described herein is not a finance or service charge imposed for the extension of credit or in exchange for forbearance in collecting any past due account. In addition to imposing a late payment charge, Frontier Supply Company, and/or The Plumbing Showcase shall be entitled to exercise all legal rights described in the following paragraph.

An account that is past due will be closed to further charges until the balance has been paid in full and Frontier Supply Company and/or The Plumbing Showcase shall be entitled to (1) execute its lien rights, (2) institute collection proceedings, and/or (3) exercise any and all other rights that it may have under law and/or contract in order to secure payment of the past due account.
